NOTES - December 2015: *Disturbance*=Both were family related. *Hit and Run*=Both were vehicle vs vehicle. *Indecent Exposure*=Occurred in parking lot near the McDonalds (subject urinated on a vehicle). *Narcotics Violation*=Two subjects charged. *Noise Complaint*=Fireworks, Music, & Loud Party. *Prowler*=Unfounded, phone number was Swatted. *Runaway*=Juvenile. *Suspicious Person*=Everything was okay, garage door was also found open.
